Alcoholics Anonymous Celebrating 75 Years in Florida

Just four and a half years after Alcoholics Anonymous had it's beginning in Akron, Ohio, Jacksonville had its first meeting at 2747 Riverside Ave. circa January 6, 1941.

A Navy commander Junius C. had been living in Pasadena, California and had a major drinking problem. He had retired from Naval Service in 1939 probably due to his heavy drinking. His wife, Maria, heard of this new organization called Alcoholics Anonymous and wrote to Ruth Hoch and Bill W. in New York and purchased a Big Book. With much resistance Junius finally read the book and may have met with some of the early AA members in Los Angeles. He achieved a few

months of sobriety at which point he was recalled to the Navy and assigned to establish Naval Training Schools at NAS Jacksonville. He arrived in Jacksonville on October 14, 1940.

Maria, fearful that Junius might start drinking again, went to the station dispensary to see if she could find an alcoholic Junius could work with. She met a Dr. Bedell, a psychiatrist, who had just been assigned to the Navy base and had a private sanitarium in Jacksonville for treating alcoholics. Marie asked him to find someone the Commander could work with to help him stay sober. Dr. Bedell picked Tom S. who he had been treating for years as a hopeless alcoholic.

Junius and Tom met in December of 1940 at Junius'base quarters. They talked for over two hours. Junius told his story to Tom and read passages from the Big Book. In Tom's words "He told me his story and read me passages from the Big Book. Immediately I had a hope I hadn't had in years, we found that we were not alone anymore. I went home and read the book until about three of four in the morning. Everything in it made sense to me then as well as it does today".

Tom and Junius stayed in contact after the first night and soon Junius said to Tom, "We have to get something started if we are going to keep this program going". Tom rounded up about five of his drinking buddies and they had a meeting in the house that Tom rented from his aunt on Riverside Ave. None of these four stayed sober.

Tom later recalled that this meeting was held sometime in the first week of 1941.

On March 1, 1941, the Jack Alexander article was published in the Saturday Evening Post. As a result of reading this article J. Mack W. of St. Augustine contacted Ruth Hoch who put him in touch with Tom and he became a regular member of their weekly meetings.

- In April of 1941 Tom S. went to the local evening newspaper and informed them of the AA movement and what they were doing locally. The Jacksonville Journal published an article on April 18th and this resulted in three men contacting Tom and joining the group. And so AA grew.
- Today there are more than 500 AA meetings a week in the Northeast Florida area.


The Northeast Florida Intergroup hosted a celebration of this first meeting on January 16, 2016, at the Central Group. This group is the direct descendent from that original group. Chaz H. chaired a panel of speakers. Fred H., past delegate, shared on the founding of AA. Charlie M. discussed the history of that first meeting and the early growth of AA in Florida. Ben W. talked about his experiences with Tom S. and Ron E. shared on his meetings with Bill W. The nephew of Junius C. was in attendance. Cakes were served which had pictures of that house on Riverside Ave. and of the Windsor Hotel where the group began meeting in mid-1941.



I smirked at the thought. She was right. I could finally see a way out of this drinking purgatory

"Oh, speak of the devil." The nurse cheerfully announced as she buzzed in the diamond of all gems, the mother to my beautiful daughter.

"We were just saying how wonderful and kind it was of you to take time out of your busy work schedule to visit with us today."

The nurse guided my wife to the seat across the table from where I was sitting.

"Your husband has something very important to tell you."

I lifted my head and caught sight of an empty expression that rested deep within my wife's eyes.

"After talking it over with a couple of doctors and nurses, I came to the conclusion that my life had become unmanageable and I am an alcoholic"

People just won't do what I think they should. They won't ACT how I think they should. They won't SAY the rights things. They don't THINK the way I do and GOSH, DARN IT, why not? After all, I know it all.

I've learned through the steps and the teachings of Alcoholics Anonymous how to live right, how to love right, and the right way to think.

It's no wonder I begin to get a little bit angry when I don't get my way. My anger turns to resentment, and that resentment begins to fester. I try harder to convince you that I am right. I begin to "hate" the way you behave. HATE. What a despicable word - one I don't care to have in my vocabulary, my emotions, or in my heart. So, negative and down the drain I go. "Wrapped in cellophane," I try to fight myself out and it doesn't work. I am miserable. I must "let go," but this is hard.

As I write this article, God has provided me with first hand difficulties of trying to let others live the life God has for them and to look at myself. When I become willing to practice love and tolerance, the answers, the peace, and the serenity come. If only momentarily.

Through my sponsor, and loved ones, and my Higher Power, my eyes are being opened to the true course of life. My life, not yours.
