- Maggie proposed an amendment to Appendix L Standing Committees, page 23 to change the wording "Special Needs" to "Accessibility". Also affects both pages 8 (Add 'Accessibilities' to the standing committee list). We may not need vote by IG body. If needed the motion reads "In Appendix Ten item L page 23 of the NEFL Intergroup Bylaws:The committee title 'Special Needs' be changed to 'Accessibility' " motion by beth seconded by Jeanne"was 7 in favor no opposed to make the change.
- Bryant suggested a wording change to Appendix K pg 21 regarding the composition of the Steering Committee. This involves the loss of discussion privileges for the district whose SC representative has been elected as the Steering Committee Chair. That may imply that the chair is to remain neutral in discussion and whose vote is required only in the case of a tie. Motion was rescinded for time to present a well-worded motion for the next meeting. Several points were given including that this idea has been brewing for at least 6 years in the SC. It deserves research and it was pointed out that our by-laws are legal documents and the exact wording is to be taken from the minutes.
