3. Keep your A.A. telephone list with you all the time. If a drinking urge or panic comes—postpone everything else until you've called an A.A. member.



4. Find out about the special holiday parties, meetings, or other celebrations given by groups in your area, and go. If you're timid, take someone newer than you are.



5. Skip any drinking occasion you are nervous about. Remember how clever you were at excuses when drinking? Now put the talent to good use. No office party is as important as saving your life.




6. If you have to go to a drinking party and can't take an A.A. with you, keep some candy handy.





#### NE FLORIDA INTERGROUP CHAIR REPORT TO THE FELLOWSHIP ON VISION

#### AND GOALS FOR 2021-2022


In the January 2021 NE Florida Intergroup business meeting we provided our vision and goals for 2021 - 2022.

1. Improve service and support for Districts 1, 3, 4, 6, 24, 25

and 30 and their Groups. Ensure Group and District meeting information is accurate and current on website and meeting guide. Publish new District Officers contact information, current boundaries and group lists. Promote District and Group activities and workshops in Add A Line and on website and Facebook. Work with the District DCM to update the list to accurately reflect the groups supported by the Districts and their current meeting format: zoom, hybrid and inperson.

We worked closely with the Districts and Groups to improve the NE Intergroup website and When and Where to include accurate information on group in-person, hybrid and online meetings. We published the information on District business meetings in the Add A Line and the District boundaries in the When and Where. Keeping the online meeting information current continues to be a challenge. We promoted District and Group activities on the website, Add A Line and in business meetings. We did not promote them on Facebook.

2. Improve Group participation in Intergroup by energetic outreach to groups by personal, Add A Line, website and Facebook invitation with information on Intergroup services, efficiency and accountability.



We reached out to the groups and Districts to increase participation with mixed results. Participation in several committees was a challenge including CPC/PI. Other committees had allot of participation and accomplishments. We had two officers and several committee chairs step down but other members stepped up and did great jobs.

3. Improve Intergroup By-Laws and Procedures. Review and update By-Laws and Office Procedures to improve operations. Examples are adding Parliamentarian appointed by the Intergroup Chair and approved by voice vote of the members, adding responsibilities to the Finance and Archives Chairs and clarifying the missions of Intergroup and its committees to support the Districts and Groups.



We updated the By Laws to make several improvements including adding a Parliamentarian, clarifying the members of the Steering Committee and changing the rotation of the Vice Chair to opposite the Chair and Treasurer. We must review and update the office procedures to reflect current operating practices.

4. Improve Intergroup business meeting effectiveness. Meetings in 2021 will be on first Saturday of month and until July all meetings will be on zoom. Meeting ID and password will be the same for all Intergroup business meetings. Zoom open at 9:30am and meeting start at 9:45am. Participants sign in with first name and last initial and Intergroup position. No introductions around room. Keep microphone to motion for approval. Committee chairs to email their monthly Committee reports to Intergroup Office, Chair and Vice Chair the Saturday prior to business meeting. Office to email the business meeting agenda the Tuesday prior to the meeting.

We improved business meeting procedures including recording meetings for more accurate meeting minutes, requiring concise officer and committee chair reports and orderly discussions. We moved meeting location to JABA Club for better access and parking and initiated hybrid meetings with a zoom host during the COVID challenge.

4. Offer fun, exciting and safe special events for fellowship and their families.

The Special Events Committee hosted two very successful Intergroup Gratitude Banquets with strong Fellowship participation and support for which we are very grateful. We look forward to the Intergroup Picnic next spring and Gratitude Banquet next fall.

It has been an honor and privilege to have been your Chair the last two years. I believe that Holly C, your new Chair, will do a truly outstanding job supporting our seven Districts and over 200 groups. I look forward to seeing you on our road to happy destiny.





The symbol of the circle and triangle is an ancient spiritual symbol meaning mind, body, and spirit together as one. In AA, this symbol represents the three parts of our program (recovery, unity, service) which are the solutions to the three-part disease of alcoholism (physical, mental and spiritual). The circle surroundingthe triangle represents Alcoholics Anonymous as a whole. The equilateral triangle is the strongest construction structure known to us. Because all three sides are equal, the triangle represents the balance required among all 36principles in order for us to stay sober.

"The circle stands for the whole world of A.A., and the triangle stands for A.A.'s Three Legacies of Recovery, Unity, and Service. Within our wonderful new world, we have found freedom from our fatal obsession. That we have chosen this particular symbol is perhaps no accident. The priests and seers of antiquity regarded the circle enclosing the triangle as ameans of warding off spirits of evil, and A.A.'s circle and triangle of Recovery, Unity, and Service has certainly meant allof that to us and much more."
