NEFL Intergroup Services Business Meeting Minutes Saturday, August 1, 2015

Carl G., Intergroup Chair called the meeting to order at 9:45am with the Serenity Prayer.

The Twelve Traditions were read. The Responsibility Pledge was recited in unison by all. The new Intergroup representatives received a welcome packet. All present introduced themselves.

Visitors – Lisa D., representing the Florida Unity Roundup coming in October, reminded the body of the kickoff fundraiser tonight at 6pm at the JABA Club. Come out and join us for an evening of fun and fellowship playing bingo and bidding on the cakes for auction.

Secretary's Report – Teri H. read the previous month's minutes.
