She said she learned that AAWS does have 3 pamphlets in the native language and is researching the translation of the Big Book, which should be out in the next year or so. Walter F. provided NEFCADA with information and history on Alcoholics Anonymous and our willingness to help. Phone Army work is some of the most rewarding, truly hands on help to the still sick and suffering alcoholic. We are proud to have this 24 hour service available in our community, many Intergroups use answering services. Requirements are 6 months of sobriety and a general knowledge of AA and the Jacksonville area.

Florida State Convention – Tom M. 1,030 people registered as of now, expect 2,800 at the convention – the remainder will register on site. Meeting today at noon at JABA with co-chairs and committee members. Laura reported on the Hospitality committee – Hospitality room will be open 8:00am to 10:00pm, will close for main speaker meeting. Group volunteers are needed for two hour timeslots. If you can't donate your time, a check earmarked for "Hospitality" will be gratefully accepted. The recent Bingo night raised \$1,400.00 for the committee. Lon L has a source for unlimited cheap coffee only in Hospitality suite. The hotel was to charge us \$6,000. At the convention in 2004 we received 200 gallons free and paid \$18,000.00 throughout the rest of the event. Scholarships – opportunity for those just coming out of treatment to attend. Anyone can make a donation to the scholarship fund on the website, \$387 donated to date. A 501(C) 3 fundraiser has to have 15-20% in scholarships.

The National convention is in Atlanta that year and it would be a strong combined effort. FYCPAA will be involved in the state convention in marathon meetings and service work.
