Steering Committee

Old Business

Candidates should have a minimum of 5 continuous years of sobriety and have service experience in AA and IG service structure.

Discussion was held on Officer Rotation:

Per Article VIII of the Bylaws states that elections for a new IG Chair, Vice Chair AND Treasurer will be held this November with their terms to begin in January 2023. Per Article VIII the Treasurer will rotate in opposite year of the Chair and Vice Chair. Recommendation was made to rotate the Vice Chair in opposite years instead of the Treasurer.

The following motion was approved by the Steering Committee, pending approval by the body: Change Article VIII of the By Laws that states "The Treasurer will rotate in opposite years of the Chair and Vice Chair to "The Vice Chair will rotate in opposite years of the Chair and Treasurer".

Group approved posting of the motion in the Add-A-Line, so it could be to be voted on by the Business Meeting in November.

New Business

Request a proposed motion from the floor to replace the sentence "The Treasurer will rotate in opposite years of the Chair and Vice Chair" to "The Vice Chair will rotate in opposite years of the Chair and Treasurer" Second. Motion will be put in the Add A Line and voted on at the November business meeting.

All other chair positions are appointed. In the spirit of rotation, we will be looking for volunteers to serve for 2023-2024.
